In 2015, Stefan joined GrandVision, a global leader in optical retailing, as Regional Director for Latin America and subsequently CEO of its Brazilian business. Stefan is 48 years old and a Swedish national.

Daniel Fehr spent almost 10 years at Barry Callebaut in various finance functions (group accounting, treasury & tax) in both Europe and Asia. In his last position, Daniel was the Head of Group Tax. Before joining Barry Callebaut, Daniel spent 8 years with PwC as accountant in Switzerland and the UK. He is 39 years old and a Swiss national.
